PLAN A - \$211.64 tax included

This is a complete annual maintenance plan. This plan includes annual tune-up and adjust your oil burner, brush and vacuum boiler or furnace flues and smoke pipes, lubricate burner and circulator motors, check controls and switches and perform an efficiency test. Change nozzle and oil filter cartridge and pump strainer (if equipped).

PLAN B - \$349.89 tax included

This plan includes all the services in Plan A & B plus Parts Insurance. Parts insurance covers the repair or replacement of defective parts on your oil burner (as listed below) for one full year from contract date. This contract covers service calls during normal working hours which are 8:00 A.M. to 4:00 P.M. Monday thru Friday. THERE WILL BE A SERVICE CHARGE FOR SERVICE PERFORMED AFTER NORMAL WORKING HOURS. Weekends and on Holidays. Service calls are only for the repair and replacement of the parts listed below. We will cover

Parts Insurance covers the repair or replacement of defective parts on your oil burner (as listed below) for one full year from contract date. Any parts necessary during a service call not listed here will be billable but No labor will be charged under the Plan C contract. **This contract also covers service calls 24 hours a day, 7 days a week, 365 days a year.**

**PLEASE READ THESE CONDITIONS OF OUR SERVICE PLANS
ALL SERVICE CONTRACTS ARE FROM JUNE 1st TO MAY 31st
TO QUALIFY FOR PLAN B OR PLAN C
YOU MUST BE ON **AUTOMATIC DELIVERY** AND YOUR SYSTEM
MUST BE INSPECTED PRIOR TO INITIAL CONTRACT SIGNING**

- Failure to buy all fuel oil from A-1 Oil Company.
- Servicing of equipment by anyone other than authorized personnel from A-1 Oil Company.
- Failure to maintain proper credit standing with A-1 Oil Company.
- These service contracts cover a one zone residential heating unit only. If you have more than one zone, **the additional zones must be covered at \$21.27 per zone under Plan B & C.**
- We reserve the right to inspect the equipment covered before accepting the service contract for Plan B and Plan C.
- The cleaning charge will revert to an hourly rate, when the heating system has not been maintained annually by A-1 Oil Company.
- General Electric heating equipment, low pressure burners, Blue Flame, Integrated pump/motor assembly, foreign or non-standard equipment and automatic stack dampers are **NOT** covered. Our plans do not cover obsolete equipment. All parts must be available thru normal sources or supply.
- Repairing and replacing the following are **NOT** covered under Plan A, B, and C: water heater, combustion chamber, heat exchanger, oil tank and lines, expansion tank, zone valves, flow check, relief valves, circulating pumps, and bearing assembly. Also, the purging of your heating systems are not covered. Anything that comes in contact with the water on the WET side of the boiler is **NOT** covered.
- These plans do not cover emergency calls resulting from your burner failure, that is caused by flood, power outage, blown fuses, tripped circuit breakers, burner switch off, no water in the boiler, automatic flue damper failure, or run outs. Oil run outs are **ONLY** covered, if the customer is on Automatic Delivery Service with A-1 Oil Company and the account balance is current. Property owners are fully responsible for vacant buildings, including oil in the tank.
- A-1 Oil Company reserves the right to cancel any heating plan for any of the following reasons **A)** failure to buy all fuel from A-1 Oil Company. **B)** servicing of equipment by anyone other than authorized A-1 Oil Company personnel. **C)** failure to maintain proper credit standing with A-1 Oil Company. A-1 Oil Company will not assume any responsibility and this agreement will be null and void if any of the above occur.
- Customers account balances must be current No balance over 30 days. Also Budget customer payments must be current.
- These plans can be transferred from the original owner to a new owner at the address shown for the unexpired term of the agreement provided that the fuel is purchased from A-1 Oil Company. These plans can be transferred from the address shown to another property subject to approval by A-1 Oil Company, provided you relocate within our normal delivery area. Contracts are not retroactive if you cancel out your plan.
- We are equipped to provide service promptly, but cannot be liable for any delay or failure to supply service or material, because of conditions beyond our control. In no event shall we be liable for consequential damages or injury.
- This agreement contains the entire agreement of the parties hereto and there are not promises, terms, conditions or obligations other than printed herein.
- These plans are automatically renewed unless, either party informs the other in **WRITING** at least 30 days prior, to the anniversary date.

We will make a reasonable attempt to contact customers for an appointment, however, it is your responsibility to ensure maintenance is scheduled. There will be no carry-overs into the following year or credits for annual service not performed.
